KOTDA/RFP/003/2016-17 GRASS CUTTING & SITE CLEARANCE AT KONZA TECHNOPOLIS PHASE 1A

The Konza Technopolis Development Authority (KoTDA) invites **PROPOSALS FOR GRASS CUTTING & SITE CLEARANCE AT KONZA TECHNO CITY**. The project broadly comprises, grass cutting and site clearance services to help manage areas that have become overgrown and need regular maintenance.

Bidders are required to demonstrate proof of trimming and cutting grass on large gardens, grass lands and on black cotton soil.

Terms of Reference

- 1. Methodology** – bidders are required to comprehensively illustrate:
 - The approach they will take to cut and package the grass
 - How they will organize their storage services to cater for packaged grass before sales.
 - How they will transport packaged grass to sales points in a way that will reduce extreme movements in and out of an already busy site.
 - Propose to the authority of possible ways to share balled grass with neighboring communities
- 2. Payment plan** – bidders should describe the available payment options and the best that they have proposed for this agreement. This should include indicative prices and how the revenue generated will be shared with the Authority.
- 3. Workplan/Duration** – bidders should illustrate the duration they will take to clear the areas.
- 4. Equipment and Machinery** – bidders should show proof of equipment & machinery that will be used for the exercise.
- 5. Key personnel** – bidders should provide CVs of key personnel who will be involved in the exercise.
- 6. Number of bidders required** - Up to five (5) qualified bidders will be selected to conduct the exercise.

Interested eligible bidders should send their proposals on or before **Friday 27th January, 2017**. Bidders will be required to email their detailed contact information to procurement@konzacity.go.ke for recording, further clarifications and addenda. In addition, all addenda will also be posted on the website as they become available.

The bidders must submit the mandatory requirement, supported by relevant documents so as to be considered for further evaluation:

3. Valid PIN Certificate
4. A visit to the site on Wednesday 25th January 2017 at 10am - 12am

Submitted bids will be opened publicly at the same venue shortly thereafter in the presence of the tenderers or their representatives who choose to attend.

Prices quoted must remain valid for One Hundred and Fifty (150) days from the date of Tender opening.
